we hereby send you an English vertion of Our decision from June 2013 in Hordaland County Council:

#### **DECISION**

- 1. Hordaland County Council is positive that Bergen will be the host city in a Norwegian application for the 2017 UCI Road World Championship, and considers this to be an attractive championship for the Bergen region.
- 2. The County Council assumes that the cost of the championship will be shared by sports, businesses and public authorities.
- The County Council assumes that funding from the national government will correspond to that of the regional government and that the municipality of Bergen and the other municipalities also contribute.
- 4. The County Council will support the event with 15 million NOK as specified in the administrative work. This amount will be put in an exemption fund during the closing of the accounts for 2012. The County Council assumes that the funds for the recommended uncertainty provision of 15, 6 million NOK is not allocated now, but that it will be provided as stipulated in the administrative work if the situation occurs. Hordaland County Council's part of this constitutes 5,2 million NOK.
- 5. The County Council agrees that an event company should be established for the 2017 UCI Road World Championship. The County Executive Board is given the authority to make a decision about whether or not the County Council will participate in such a company.
