4) Factsheets:

The aim and status of the factsheets on energy transition were discussed. A paper version will be issued, and a webversion will be put on the NSC website. (action Paulien). The document shall be revised every 6 months, every region will be asked to give an update. Jimmy Gray, Highlands will look into the possibility of sharing documents on a protected website. (action Jimmy Gray)

Southend-on-Sea and Lower Saxony will organise input for the factsheets (Paulien will send the template factsheet). Other regions are also asked to give their input asap.

- 5) Presentations by Louise Napier (Aberdeen), Tale Halsør (Hordaland), Guri Bugge, (Ostføld), Johan Scholte (Drenthe)
- -Presentations on the role of Hydrogen (and biofuels) for clean transport and greening the chemical sector in the regions were given by Hydrogen by Hordaland, Ostfold and Aberdeen. A presentation of Drenthe focussed on Hydrogen in the EU Clean Energy Package, national and EU policies, funding and creating a level playing field.

The discussion focussed on what concrete actions for our group could be identified, with the following outcome:

-A position paper on hydrogen will be prepared (Actions by Johan, Louise, Guri, Tale and Paulien). Issues to be taken into account are:

- -charging infrastructure compatibility of pay systems between countries;
- -safety issues;
- -level playing field for hydrogen as an unproven technology, position of hydrogen in the national energy and climate plans and regional energy plans.
- -requirements for various vehicles, what are the costs, not only transport but also greening chemical industry.
- -Intervene in the green car, electric cars dialogue within the public sector, start a dialogue.
- -present the position paper at Wind needs Gas summit on 18, 19 October 2018, Groningen.
- -There is an interest to develop joint projects on hydrogen, Johan will send out a project idea for Interreg Europe
- -we could work on and initiate specific reports and communicate them at a national level, in Brussels etc.
- -organise events at the European Parliament (Aberdeen and Aragon organise an event during the European week of regions and cities October 2018, (information will be distributed)
- -lobby actions towards EU legislation on clean energy and mobility
- -make connection to the CPMR work in this field
- -Paulien will circulate the 4 presentations
- 8) A combined event with the transport group Q1 2019
- -Paulien will look into the work on hydrogen of the transport group to prevent an overlap in activities
- -a joint event with the Transport group could perhaps take place in Brussels. This will be discussed with the Transport group.
- 9) Update on actions on the off shore wind political cooperation around the North Sea by the taskholders Hordaland, Groningen, Lower Saxony.
