Local Municipalities Cultural Mapping Program

This program is based upon these cornerstones:

1. Knowledge and competence
2. Co-operation
3. Cultural Heritage Planning
4. Documentation

Documentation is facilitated by the implementation of low-threshold digital tools ("Kulturminnesøk"), developed by The Norwegian Directorate for Cultural Heritage, which allows a broader audience to fill in heritage information concerning their neighboring surroundings.

The process of gathering information, mapping local cultural resources, is intended to provide public authorities with a better platform for cultural management and integrated planning. Key opportunities rising from this, is Analyses of Conflicting Interests, and Risk Assessment.

Owner-focused interface

Hordaland wants to create a user-friendly and interactive interface between owners of cultural monuments on the one side, and public heritage management systems on the other. Today, heritage documentation is scattered around several IT-systems, and most of them are designed for professional use, only. To a certain degree, this sub optimizes the possibilities for insight and knowledge access by the owners of built heritage and by the

landowners. In some cases different owner groups can be left with unintended fragmented information.

With this new interface being developed and implemented, it will be possible for owners of historic buildings and sites, to log in and click on a "my property" button and find all relevant registered public information (for instance, why the building have been listed, what maintenance should be done and how, how to come into contact with a desk officers for advice etc.)

It is important for us to stress that this initiative is not to create new databases or new ICT-systems, but to make better use of the ones already operating.

Hordaland County Council co-finances 6 building preservation consultants, employed by the different museums and acting as an outreach branch of the County Conservator's Office. Their purpose is also to act as advisors for private owners and local municipalities. Combined with the new interface, the planning and use of this new manpower can be made more efficient, thus counteracting the ever increasing problem of cultural heritage loss, partly due to climate impact.

The interface may also contain:

- Application guide – ta make it easier to find the wright application form and guide to how to fill it in
- Help to establish "FDV" (Management, Operation, and Maintenance) applied to each object
- Useful information about do-it-yourself maintenance
