#### 7 DISPUTES





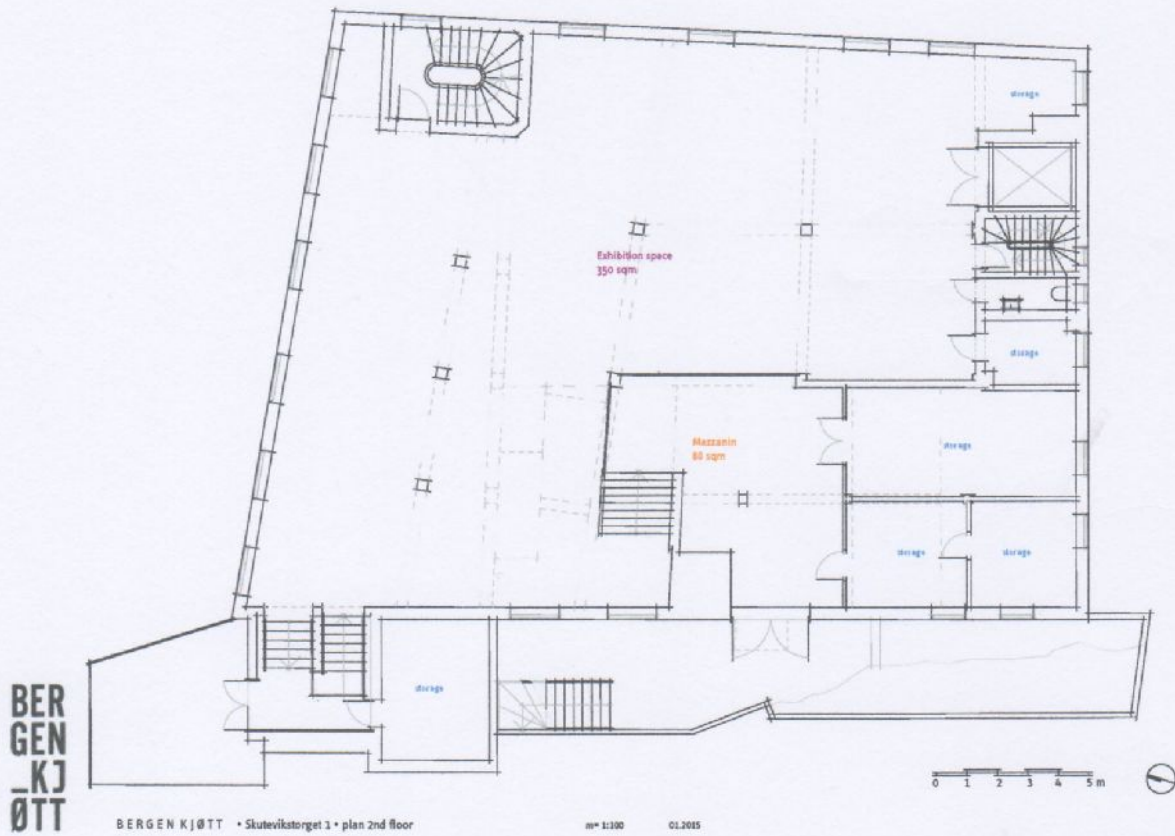
