It was lovely to meet you on Monday. Hope your journey home went smoothly – especially the taxi ride to the airport!

Thought I would send you some notes from the meeting, for information.

1. Potential ideas for future Erasmus+ projects involving schools (KA1 or KA2):
 - Robotics in healthcare (possibly linking with Denmark as market leaders);
 - Cycling project – also touches upon healthy living and liveable cities, and links in well with the World Cycling Championship taking place in Bergen in 2017;
2. Current Hordaland KA2 projects:
 - The City Rings 2015-18 – focusing on soundscapes of cities
 - Integration of migrants;
3. Emily to send you more details on opportunities through the ELAN network.
4. Look into holding a special 'Farewell ceremony' for the 2016/2017 class to mark the 20th anniversary of the Hordaland-Cardiff schools link.
5. Find out how students currently receive their A/S level results and enquire whether it's possible for the results to be sent to the schools in Hordaland and/or Hege Cruickshank as soon after their release as possible. This is to ensure schools are made aware of any required resits before the 15th of September deadline.
6. I will speak to my manager about sending another invitation to Hordaland's Director of Education to visit Cardiff in the near future – perhaps we can link this visit up with the Farewell ceremony in June?
